STALLION SERVICE CONTRACT

Has engaged one AI breeding service to the stallion "**Clovercroft's Abba Adonai**",
a registered Sec B welsh Stallion for the said mare _____.

Breed Description & registration # of Mare being bred _____

1. The service covers the 2009 season at the stud fee of \$650. The stud fee must be returned with contract. The stud fee must be paid before arrival, collection and insemination and or shipment.

2. The balance of the stud fee and other expenses must be paid when the mare's owner is invoiced. A service charge of 1.5% per month (18%per annum) will be charged on all unpaid balances over 30 days.

3. **Windy Way Welsh Ponies** must approve the mare owner's choice of licensed veterinarian for AI of shipped semen before the contract is binding.

4. A current picture of mare to be bred and all paperwork signed must be sent to Windy Way Farm c/o Lauralee Purnell, before the contract is binding.

5. The contracted service includes the Stallion service fee only.

The mare's expenses, other than stud fee, will all be paid to:

Harris Paints by the mare owner. Including but not limited too, stall and feed, vet checks, inseminations, collections. Stud fee will be paid to Windy Way Farm Welsh Ponies LLC.

6. **Veterinarian Certificates:** Mare Owner warrants that said mare is free from disease or infection that could be transmitted to other horses, and agrees to provide, upon arrival, a veterinarian certificate, showing freedom from disease or infection. This shall include proof of a negative Cog gins test for EIA within one year of arrival. Stallion Owner and or farm owner reserves the right to reject any mare that is in poor condition or one that is unmanageable. Mares that are not halter broken will not be accepted.

MARE must have recent uterine culture and be up to date on all vaccinations and worming. -Culture may be done upon arrival at Harris Paints at owner's expense. Harris Paints must be notified prior if this is needed.

AI for off the farm: The mare owner will pay Harris Paints prior to all shipping and

handling expenses, (including collection) and a refundable container deposit fee of _____, refunded when the equitainer is returned within 24 hours after the last insemination. If returned late a penalty fee is assessed. All Fees must be paid in full before shipment.

7. You cannot assign this agreement, if the mare is sold the fee shall be due immediately and the live foal guarantee will be immediately null and void. No fees will be refunded under any circumstances.

8. **Windy Way Welsh Ponies** guarantees a live foal from the said breeding, meaning the foal shall stand and suck. If the foal is stillborn or dies before nursing, the mare owner will be entitled to return for the stud service with no stud fee. This contract is good for 2 consecutive breeding seasons to said mare. All mare-boarding expenses will be paid by mare owner; including collection, inseminations, any handling, shipping and vet fees. This guarantee will apply only if notification is sent by registered mail within 48 hours of foal's death. Statements of details by a licensed veterinarian must follow within 10 days or guarantee becomes null and void this clause is also binding in case of abortion.

Mare Owner is required to give 3 vaccinations of Pneumobort K to pregnant mare during 5th, 7th, and 9th month of gestation. Mare Owner is encouraged to prevent mare's ingestion of endophyte fescue grass or hay for at least 3 months prior to expected delivery date of foal.

9. Should said stallion die, become unfit for service, be sold, or the lease on the stallion terminates, before the successful breeding, stud fee or deposit paid will be refunded.

10. Mare is to be checked at 15 days for being in foal. Notify breeder of veterinarian's results at 30 days. Upon notification of mare being certified in foal at 90 days, a breeders certificate will be sent to the mare owner. A stallion service report will be sent to WPCSA by December of the breeding year. The mare owner is responsible for registration of the foal. * Refer to WPCSA rules for foal registration.

11. When **Windy Way Welsh Ponies** and the mare's owner sign this contract, it will then be a binding contract on both parties subject to all above terms and conditions.
